**4.1A.** Winter Carp Seine Update: Jeff Anderson. On January 29<sup>th</sup> Commercial Fisherman were hired to sein carp on Upper Prior Lake near Knotty Orr Marina. The usual seining net was used and a second gill net. A sound device was used to move carp to preferred area. 150 carp were removed totaling 2,300 pounds of carp. The amount removed was less than the hoped for amount. Carp can learn fast and be very elusive. The area to the south east of the sein area that the carp prefer has a lot of rocks making this area complicated for carp removal. Seining carp can be a hit or miss. A large hit / bullseye is hoped for going forward with the removal of a great number of carp.

**4.1B.Sutton Lake Outlet Project Update:** A contract has been signed with Veit Construction. Manager Hennes requested partner notification for viewing during construction. This is a water storage / water quality project with additional benefits. Target date completion March 1<sup>st</sup>.
